

### Q1 What is your highest academic qualification?






#### Q2 What is the subject of your highest qualification?

# Q3 When did you last take part as a learner in a training activity related to your work (either online or classroom-based)?



### Q4 What is your employment status? Please select all that apply.




### Q5 How many years have you worked as a technical communicator?




### Q7 How many technical communicators do you typically work with?



#### Q9 What sector(s) do you typically work in?





#### Q11 Where do you generally work?











### Q18 For employees only: Have you had a pay rise in the last 12 months?










# Q22 Are you a member of the ISTC, and if so, what is your membership grade?


